It is notified to all concerned that online process to fill application forms for affiliation in Law (extension of provisional/permanent) for the academic session 2022-23 and onwards is being started as per below date schedule. Further affiliation fee structure (Per Course), date schedule and terms & conditions are mentioned here under:-

1. Affiliation fee structure & Date schedule for the academic session 2022-23 are as follows:-

2. **The Cost of online affiliation form will be Rs. 1,000/- per affiliation form.**
3. The Colleges applying for affiliation are required to pay **Inspection fee of Rs. 25,000/-** per affiliation form.
4. The hard copies of the form and documents to be deposited by the college in the Academic-II Section of the University within seven days from the expiry of date of online affiliation form given by the University. **Failing which Rs. 500/- per day will be charged from the concerned college that too upto 06.02.2022.**
5. The procedure has been devised, considering the affiliation rules being followed at University of Rajasthan, Jaipur. However, if need more details may be sought from the colleges.
6. The existing Colleges will be required to fill up AISHE code provided by the MHRD and NAAC certification by the UGC.
7. The college will carefully choose the category of affiliation i.e. Fresh/Extension/Increase Intake/Additional Subject/Permanent otherwise neither the category will be changed nor the fee will be returned/adjusted.
8. The affiliation fee will be deposited by respective college in the following bank and proof the same required to be attached with the form.
