



Notification

Presently, classes of academic session 2021-22 are being run in the various Law Courses in the affiliated colleges based on the provisional placement permitted to them vide University order no F4(3)/Exam. /ALU/ 2020-21/ 2324 dated 30.07.2021 or as per fresh admission in the first year/ first semester in 2021-22. These students have completed studies in their respective classes. Further, the examinations are likely to be conducted in the month of August 2022. Therefore, in the academic interest of the students, following instructions are passed for the provisional placement in their respective higher class:

1. For LL.B. Three Years course-

- a) Admitted Batch 2020-21: Result of First year Main Examination session 2020-21 including Revaluation results of the candidates those have been admitted afresh and enrolled in the session 2020-21 have already been declared by the University.

These candidates were provisionally placed on 2nd August, 2021 in LL.B. Second year vide order no. F4(3)/Exam. /ALU/2020-21/2324 dated 30.07.2021. Now, these candidates are supposed to appear in LL.B. Second year examination which is likely to be held in the month of August 2022.

The students who were provisionally placed under the aforesaid order dated 30-07-2021 have already completed their studies, therefore it is notified that the students of LL.B. Second Year (Three Years Course) need to be placed in the Third year of the Programme w.e.f. from 11th July 2022. So, their classes for the Third Year may commence accordingly.

These candidates may only continue in the provisionally placed class subject to obtain the eligibility for this class after appearing in the examination of LL.B. Second year 2021-22.

- b) Admitted Batch 2021-22: The examination of the candidates of LL.B. First year enrolled in the session 2021-22 is due and they have also completed their course of LL.B. First Year. Further, they have to appear in ensuing examination of LL.B. First Year 2021-22. Therefore, these students of LL.B. First Year also need to be provisionally placed in the second year of the Programme w.e.f. 11th July 2022. Their classes for the second year may commence accordingly. These candidates may only continue in the provisionally placed class subject to obtain the eligibility for this class after appearing in the LL.B. First year examination 2021-22.

2. For LL.M. Two Years course-

- a) The examination of the candidates of LL.M. First year enrolled in the session 2021-22 is due and they have also completed their course of LL.M. First year. Further, they have to appear in ensuing examination of LL.M. First year 2021-22. Therefore, these students of LL.M. First year also need to be provisionally placed in the second year of the Programme w.e.f. 11th July 2022. Their classes for the second year may commence accordingly.

These candidates may only continue in the provisionally placed class subject to obtain the eligibility for this class after appearing in the LL.M. First year examination 2021-22.

Note: In this respect no recommendation is required for P.G. Diploma courses (one year programme).

3. For B.A.LL.B./ B.B.A.LL.B. Five Years course-

- a) Admitted Batch 2020-21: Examination results of 1st and 2nd Semesters of B.A.LL.B./ B.B.A.LL.B. (5 Year course) session 2020-21 including Revaluation results of the candidates those were admitted afresh and enrolled in the session 2020-21 have already been declared by the University.

These students have already been admitted in 3rd Semester. So, the colleges are required to complete the course study for these students who are now studying as regular student in 3rd Semester of B.A.LL.B./ B.B.A.LL.B. (5 Year course) up to second week of September 2022, so their examinations may be conducted accordingly.

In furtherance, these students after the completion of 3rd Semester examinations may provisionally be placed in next higher semester as usual without waiting for declaration of results.

These candidates may only continue in the provisionally placed class subject to obtain the eligibility for this class after appearing in the existing semester examination 2021-22.

- b) Admitted Batch 2021-22: Examination results of 1st Semester of B.A.LL.B./ B.B.A.LL.B. (5 Year course) session 2021-22 including Revaluation results of the candidates those were admitted afresh and enrolled in the session 2021-22 have already been declared by the University.

These students were admitted in 2nd Semester and studying as regular student in 2nd Semester of B.A.LL.B./ B.B.A.LL.B. (5 Year course). Their examinations may likely to be held in the month of August 2022. So, the colleges may arrange the teaching plan in such a way to complete their course study within the stipulated time.

In furtherance, these students after the completion of 2nd Semester examinations may provisionally be placed in next higher semester without waiting for declaration of results.

These candidates may only continue in the provisionally placed class subject to obtain the eligibility for this class after appearing in the existing semester examination.
