GUIDELINES RELATING TO CONDUCT AND EVALUATION OF EXAMINATIONS FOR PROGRAMME OF B.A.LL.B./ B.B.A. LL.B. FIVE YEARS (INTEGRATED COURSE) FOR AFFILIATED COLLEGES:

The B.A.LL.B./ B.B.A.LL.B. Five Years (Integrated Course) for Affiliated Colleges shall be of Five Years (Semester Scheme). These guidelines shall be in force from the session 2020-21.

Following modifications are suggested in the present prevailing Examination scheme of B.A.LL.B./ B.B.A.LL.B. as well as Grace and Revaluation rules.

These following benefits shall only be allowed for admitted batch 2020-21 prospectively from the examination 2021-22 (not in the examination for which results have already been declared i.e. I & II Sem.) and also applicable on the admitted batch 2021-22 prospectively from the ensuing II Semester examination 2021-22 (not in the examination for which results have already been declared i.e. I Sem.). These benefits shall only continue for next onward semester examinations. The text of the modified rule is as follow:

> ELIGIBILITY FOR APPEARING IN THE END-SEMESTER EXAMINATION:

A student shall be required to have a minimum attendance of 75% or more in the aggregate of all the courses/papers taken together in each semester subject to the University rules and regulations in force from time to time. A Student who has been detained due to shortage of attendance shall not be promoted to the next Semester and he/she will be required to take fresh admission as regular student.

The college has to submit the names of all such students to the University who are not eligible to appear in the Semester Examination, before its beginning. In case any student appears by default, who in fact has been detained by the University or college, his / her result shall be treated as null and void.

The candidates who are eligible for promotion from the existing Semester in which he/she is taking the Examination of B.A.LL.B./ B.B.A.LL.B. course to the next Semester shall take re-admission by submitting his/her application form along with the prescribed fee within the prescribed time. However, in case of late-admitted candidates in the running Semester (but within the stipulated time), the attendance will be reckoned from the date of admission of the candidate.

> EXAMINATION & EVALUATION:

- a. The university shall hold examinations for awarding Bachelor's Degree in Law B.A.LL.B./ B.B.A.LL.B. Five Years (Integrated Course) as per the prescribed Scheme of Teaching and Examinations and Syllabi which will be evaluated through Semester Examinations.
 - b. (i) The schedule of examination for total fifty papers [16 Arts/Business Administration Papers and 34 Law Papers {including 04 Clinical/Practical Papers of Law}] shall be notified by the University at least 10 days prior to the first day of the commencement of Semester Examinations. Each End Term examination paper shall be of three hours duration and carry 100 Marks subject to the division of Marks detailed in the syllabus.
 - (ii) For Semester Examinations theory as well as project report/viva-voce/other practical's, external examiners shall be appointed by the University.
- c. (i) A candidate for passing the B.A.LL.B./ B.B.A.LL.B. Five Years (Integrated Course) Examination will be required to obtain minimum 36% marks in each paper separately and 50% in aggregate, of all the papers in the B.A.LL.B./ B.B.A.LL.B. Five Years (Integrated Course) Examination separately in each Semester, as the case maybe.

Division shall be awarded on the combined results of all Semester Examinations during the course taken together.

(ii) All successful candidates who obtain 60% marks of the total aggregate shall be placed in First Division and those who obtain not less than 50% but below 60% of the total aggregate marks shall be placed in Second Division. A candidate obtaining aggregate of 75% and above marks shall be placed in First Class with Distinction, provided the candidate has passed all the papers/courses in the first attempt in each semester without any Grace Marks. Division shall be awarded on the combined result of all semester examinations.

Ranking shall be based on the aggregate marks secured for all the papers of all Academic Years together only availing the first chance by the candidate for all the examinations. Separate ranking will not be there for each of the subjects/semesters. However, the result of Revaluation shall not affect the merit obtained by the Candidate in the main examination.

► B.A.LL.B./ B.B.A.LL.B. EXAMINATION:

- a. (i) A Candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in minimum three (03) Papers in the B.A.LL.B./ B.B.A.LL.B. End-Semester Examination may provisionally be admitted to the next Semester. Each Candidate offering himself/herself for any Semester Examination shall be examined in all the five papers in which he/she has pursued the regular study during the course provided as per the syllabus of the respective Semester.
 - (ii)Such candidate who is promoted from existing Semester in which he/she has pursued the study during the course as a regular student to the next Semester may only reappear in consecutive two semester examinations when conducted for the failed declared paper(s) as per the syllabus then in force, to clear his/her previous papers of that Semester, failing which he/she has to clear all the papers of that semester as an Exstudent. Each End Term examination paper shall be of three hours duration and carry 100 Marks subject to the division of Marks detailed in the syllabus.
- b. (i) A candidate admitted for the degree of B.A.LL.B./ B.B.A.LL.B. Five Years (10 Semesters) Integrated Course has to complete his/her degree within seven (07) academic years beginning from the academic year in which he/she has taken first/fresh admission in the B.A.LL.B./ B.B.A.LL.B. Course as a regular student.
 - (ii) Thereafter, attending a regular course of study for each Semester, he/she may be permitted to appear in the next consecutive Semester Examination subject to the condition that a candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in minimum three Papers in the B.A.LL.B./B.B.A.LL.B. Semester Examination may provisionally be admitted to the next Semester, failing which he/she has to clear all the papers of that semester as an exstudent in ensuing examination of that semester. Such candidate if he/ she fails in first semester examination shall not be admitted in third semester until he/ she Pass the first semester examination. Further, the candidate if he/ she fails in second semester examination shall not be admitted in fourth semester until he/ she Pass the semester examination. The same rule shall be applicable and followed on the subsequent semester examinations onwards.

Progressive promotion in next higher semester's are detailed out as below:

- 1. A candidate who has completed a regular course of study in the I and II semester of B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at B.A.LL.B./ B.B.A.LL.B. I and II semester examinations respectively. Same process shall be followed in onward semesters.
- 2. A candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in atleast 3 papers of semester I and has completed a regular course of study of the III semester of the B.A.LL.B./ B.B.A.LL.B. shall be

eligible to appear at the B.A.LL.B./ B.B.A.LL.B. III semester examination. Otherwise, he/she shall appear in examination of semester I as an Ex-student.

- 3. A candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in atleast 3 papers of semester II and has completed a regular course of study of the IV semester of the B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at the B.A.LL.B./ B.B.A.LL.B. IV semester examination. Otherwise, he/she shall appear in examination of semester II as an Ex-student.
- 4. A candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in atleast 3 papers of semester III and has completed a regular course of study of the V semester of the B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at the B.A.LL.B./ B.B.A.LL.B. V semester examination. Otherwise, he/she shall appear in examination of semester III as an Ex-student.
- 5. A candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in atleast 3 papers of semester IV and has completed a regular course of study of the VI semester of the B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at the B.A.LL.B./ B.B.A.LL.B. VI semester examination. Otherwise, he/she shall appear in examination of semester IV as an Ex-student.
- 6. A candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in atleast 3 papers of semester V and has completed a regular course of study of the VII semester of the B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at the B.A.LL.B./ B.B.A.LL.B. VII semester examination. Otherwise, he/she shall appear in examination of semester V as an Ex-student.
- 7. A candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in atleast 3 papers of semester VI and has completed a regular course of study of the VIII semester of the B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at the B.A.LL.B./ B.B.A.LL.B. VIII semester examination. Otherwise, he/she shall appear in examination of semester VI as an Ex-student.
- 8. A candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in atleast 3 papers of semester VII and has completed a regular course of study of the IX semester of the B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at the B.A.LL.B./ B.B.A.LL.B. IX semester examination. Otherwise, he/she shall appear in examination of semester VII as an Ex-student.
- 9. A candidate who has obtained minimum 36% marks in each paper separately and 50% in aggregate, in atleast 3 papers of semester VIII and has completed a regular course of study of the X semester of the B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at the B.A.LL.B./ B.B.A.LL.B. X semester examination. Otherwise, he/she shall appear in examination of semester VIII as an Ex-student.
- c. The Candidate who has opted for re-appearing in the examination shall only be entitled for the marks obtained in that examination and his/her theory paper(s) marks already obtained in rest of the papers previously in End-Semester examination, the same shall be carried forward for making his/her End Semester Result. A candidate who fails in any of the paper(s) or secures 36% marks in individual paper but could not secure 50% marks in aggregate in the Semester examination of B.A.LL.B./ B.B.A.LL.B., afterwards he/she opted to reappear in such paper additional paper (as the case may be), then, he/she may be allowed to choose to reappear in same failed paper(s) and any one more other paper(s) also for the purpose of making the aggregate of 50% of marks in the Semester, subject to condition that in any case the number of such re-appearance paper shall not be more than two papers for each semester.
- d. A candidate who has attended a regular course of study and passed any Semester Examination of B.A.LL.B./ B.B.A.LL.B. from any affiliated college of this University for taking admission to any other affiliated college in the next Semester Examination shall be eligible for admission only subject to the transfer rules made by the university and he/she has cleared all the papers of semesters in which he/ she has appeared.

other required conditions provided by the University as the case may be.

A Candidate who has appeared in End-Term Examination of any Semester and the result has not been declared, may be eligible for provisional admission to the next semester for taking the classes but such provisional admission shall stand automatically cancelled if he/she could not get the requisite eligibility on the declaration of his/her result of the end term semester examination in which he/she has appeared in the immediate preceding semester.

A candidate who has pursued a regular course of study in any Semester of B.A.LL.B./ B.B.A.LL.B. shall be eligible to appear at the next following B.A.LL.B./ B.B.A.LL.B. Semester End-term examination subject to that he/she has completed the warranted attendance and fulfils

> REVALUATION:

If a student is not satisfied with the marks awarded to him/her in any paper/papers of B.A.LL.B./ B.B.A.LL.B. Semester Course then he/she shall be entitled to apply for revaluation in such paper/papers on a form prescribed for that purpose by the University.

The revaluation is permitted only in maximum three (03) theory papers in each Semester for the evaluation of the end term examination. There shall be no revaluation permitted for Practical/Clinical Papers/ Projects and Dissertation, if any. Candidate can also apply for Revaluation in Back papers.

Student shall have to apply for revaluation within One Month from the date of the declaration of the result of the end term examination or date decided by the University for the said class. There shall be a revaluation fees for each paper(s) as prescribed by the University.

> AWARD OF DEGREE:

A student shall be awarded B.A.LL.B./ B.B.A.LL.B. FIVE YEARS (INTEGRATED COURSE) Degree if:

- (i) He / She has enrolled himself/herself, as a regular student, undergone the course of studies, successfully completed the examinations/other practical /Viva-voce as specified in the curriculum within the stipulated time and secured the minimum Marks in all the Semesters.
- (ii) There are no dues outstanding in his/her name
- (iii) No disciplinary action is pending against him/her.

RULE FOR GRACE MARKS:

Grace to the extent of 1% (to be rounded off at higher side, in case of fraction) of the Max. Marks in the respective appeared examination be awarded only in Maximum two individual paper(s) subject to the condition that the candidate should declare 'Pass' in respective examination by awarding this Grace. Such, Grace shall only be awarded either of individual paper(s) or in aggregate to 'Pass' the examination by the candidate.
