Dear Sir/Madam,

This is in continuation of the Government Letter No. 15 (5) education-4/2020 dated 22nd July, 2020 followed by a letter No. 19/2020 on dated 27<sup>th</sup> July, 2020 written by the undersigned to you and subsequent communications by the Registrar Dr. Bhimrao Ambedkar Law University to the Registrar of your university.

As you are aware that all the Law Colleges affiliated with other Universities of the state ((Except Constituent Law Colleges of Universities) shall run their present academic session 2020-21, only after obtaining affiliation from Dr. Bhimrao Ambedkar Law University, Jaipur.

The affiliation process of the said colleges for the academic session 2020-21 was already underway and approaching the final stage with the respective universities when the said Government order (with the provision that all Law Colleges will be affiliated with Dr. Bhimrao Ambedkar Law University, Jaipur) was issued.

The purpose of this letter is to enable a smooth transition of this affiliation process from the respective universities to Dr. Bhimrao Ambedkar Law University, Jaipur. In this regard, it would be appreciated to kindly complete the affiliation related process at the earliest and provide the list of all such colleges with documents and specific assessment with regard to whether the colleges are fit or unfit (after inspection) for affiliation for the session 2020-2021, keeping in view that none amongst these colleges are left out of the affiliation process due to lack of clarity on the subject.

I look forward to an early response at your end in the academic interest, to enable Dr. Bhimrao Ambedkar Law University to process the same, without further delay.
