- The Cost of online affiliation form will be Rs. 1,000/- per course per affiliation form.
- The Colleges applying for affiliation are required to pay **Inspection fee of Rs. 25,000/-** per course per affiliation form.
- The hard copies of the affiliation form and documents to be deposited by the college in the University within seven days from the expiry of date of online affiliation form given by the University, **failing which Rs. 500/- per day will be charged from the concerned college upto 31.10.2023.**
- The procedure has been devised, considering the affiliation rules being followed at University of Rajasthan, Jaipur. However, if need more details may be sought from the colleges.
- The existing Colleges will be required to fill up AISHE code provided by the MHRD and NAAC certification by the UGC.
- The college will carefully choose the category of affiliation i.e. Fresh/Extension/Increase Intake/Permanent otherwise neither the category will be changed nor the fee will be returned/adjusted.
- The affiliation fee will be deposited by respective college in the following bank and proof of the same must be attached with the affiliation form.**
