## **SEARCH FOR DIRECTOR (ACADEMICS)**

*Chandigarh Judicial Academy, a Society registered under the Societies Registration Act, 1860, has been established by Punjab and Haryana High Court to organize and impart Induction Training to the newly Recruited Judicial Officers and also to devise/organize Refresher Courses/Training programmes /Advance Courses /Work Shops /Conferences/Seminars in order to provide continuing judicial education and training to the In-service Judicial Officers.*

- ❖ Chandigarh Judicial Academy proposes to fill the post of Director (Academics) and solicits the consent and curriculum vitae from distinguished academicians having teaching experience of at least 15 years and experience as Professor of Law not less than 03 years.

### ❖ **TERMS AND CONDITIONS**

- The tenure of the Director (Academics) of Chandigarh Judicial Academy shall be for 3 years which can be extended for a period not exceeding three years under Rule 20(5) of Chandigarh Judicial Academy Rules, 2009.
- The age of the applicant should not be more than 65 years of age as on last date of submission of application.
- The incumbent shall be entitled to a consolidated pay of Rs. 1,50,000/- per month excluding the retiral benefits, if any, already drawn.
- The incumbent will be governed by such terms and conditions of services as may be determined by the Patron-in-Chief on the recommendation of the Board of Governors of Chandigarh Judicial Academy.
- The incumbent shall not be entitled to any other allowance, like, HRA or medical allowance but shall be entitled to an official Car with 150 litres of petrol.
- Telephone facility at the residence (option may be given out of landline or Mobile) with maximum limit of Rs. 2000/- per month, shall be provided.
- The incumbent shall be entitled to 15 days casual leave in a year, besides other Gazetted/ notified holidays.

- The service contract can be brought to an end with an advance notice of three months by the appointee or by the Patron-in-Chief at the recommendation of Board of Governors.
- For any question regarding the terms and conditions of appointment, the decision of the Patron-in-Chief shall be final.
- Interested individuals may apply giving detailed CV alongwith a brief-note of his/her vision statement on the standards of Judicial Education.
- Utmost confidentiality of the CV and consent shall be maintained.

The aforesaid terms can be varied in a given case with the approval of the Board of Governors and the Governing Body which shall have the power to relax the said conditions.
