**Sub:-Regarding affiliation of all Law Colleges (Except Constituent Law Colleges of Universities) in the State of Rajasthan with Dr. Bhimrao Ambedkar Law University, Jaipur for the Academic Session 2020-21.**

**Dear Sir/Madam,**

This is in continuation of the Government Order No. 15 (5) education-4/2020 dated 22<sup>nd</sup> July, 2020 followed by two communications dated 27<sup>th</sup> July 2020 and 15<sup>th</sup> October, 2020 by the Hon'ble Vice-Chancellor of Dr. Bhimrao Ambedkar Law University, Jaipur addressed to the respective Vice-Chancellors and subsequent communications by the undersigned to all the respective Registrars, on the subject mentioned above, which are available at University website www.alujaiipur.ac.in.

The matter was discussed in the BoM meeting dated 7<sup>th</sup> November, 2020 and resolved as under:

- a. "All existing law colleges (except constituent colleges of other universities) in the State of Rajasthan which have been found fit by the respective universities for affiliation for the academic session 2020-21, shall be considered Deemed to be Affiliated with Dr. Bhimrao Ambedkar Law University, Jaipur for the present academic session 2020-21 upon receipt of the relevant documents from the respective Universities, and accordingly all such colleges shall be eligible to admit students in the first year of undergraduate and postgraduate law courses during the present academic year 2020-21.
- b. All students admitted in first year of undergraduate & postgraduate law courses in all such law colleges, as mentioned in 'a' above, shall be enrolled only with Dr. Bhimrao Ambedkar Law University, Jaipur and will be governed accordingly."

Accordingly, you are requested to kindly complete the process relating to the affiliation documentation, as due on your part at the earliest so that the eligible colleges may be considered for granting "deemed to be affiliation" status for the Academic Session 2020-21 by this University.
