- 2. Cost of online application form for affiliation shall be Rs. 1000/- per program.
- 3. The colleges applying for affiliation are required to pay Inspections fee of Rs. 25,000/- per course.
- 4. The colleges having permanent affiliation are required to pay only Inspections fee of Rs. 25,000/- and cost of application form Rs. 1,000/- per course.
- 5. Hard copy of application for affiliation shall be submitted within 10 days of submitting online application for affiliation, for example, if applied online on 20th July, then the hard copy shall be submitted on or before 29th July, failing which Rs. 500/- per day will be charged from the concerned college up to 15.10.2024. After this date hard copy cannot be accepted.
- 6. The existing colleges will be required to fill up AISHE code provided by the MHRD and NAAC certifications by the UGC.

7. Each college will carefully choose the category of affiliation i.e. Fresh/Extension/Increase Intake/Permanent otherwise neither the category will be changed nor the fee will be returned/adjusted.

The affiliation fee will be deposited by respective college strictly in the following bank account and proof of the same must be attached with the affiliation form. No other mode

of payment will be accepted.
