विषय : एल.एल.बी. तीन वर्षीय डिग्री कोर्स (सेमेस्टर सिस्टम) के आन्तरिक मूल्यांकन के संबंध में दिशा-निर्देश बाबत।

महोदय/महोदया,

विश्वविद्यालय द्वारा सत्र 2024-25 से एल.एल.बी. तीन वर्षीय डिग्री कोर्स (सेमेस्टर सिस्टम) लागू किया गया है। सम्बद्ध महाविद्यालयों द्वारा आन्तरिक मूल्यांकन के संबंध में गार्डिलाईन्स मांगी जा रही हैं। इस संबंध में आन्तरिक मूल्यांकन हेतु विस्तृत गार्डिलाईन्स सक्षम अनुमोदन पश्चात् जारी की जा रही हैं:

Guidelines relating to Conduct of Internal Assessment – Mid Term and Project from the Academic Session 2024-25 for LL.B. Three Year Course (Semester Scheme) to be followed by all the affiliated colleges running LL.B. Course.

- (1) The present guidelines are based on the Examination Scheme mentioned in the Syllabus and Course content of the course.
- (2) The candidate is required to obtain minimum 07 marks separately out of 20 marks in Internal Assessment.
- (3) (a) The Mid-Term Examination shall be conducted by the Internal Examiners of the concerned College. It shall be conducted after 45 days of the commencement of classes/teaching of the running Semester, but not prior to completion of half of the syllabus prescribed for that semester.
(b) The Project shall be conducted by the Internal Examiners of the concerned College. It shall be conducted after 75 days of the commencement of classes/teaching of the running Semester or almost completion of the course of the running Semester.

Office of the Controller of Examinations shall notify the schedule for conducting the Mid Term Examination, for maintaining the uniformity.

For I Semester Mid Term Examination 2024-25, the last date is decided as 28.02.2025. Online Portal for submission of records shall be opened separately.

- (4) Colleges shall submit the marks and attendance of Internal Assessment (Mid Term and Project) at online portal one month before the commencement of the End-Term Examination of the running Semester. In case of failure, the marks shall not be considered by the University for preparing the result.
- (5) Colleges shall make all the necessary arrangements for conduct of the Internal Assessment i.e., Mid Term Examination and Project at their own.

Note:-

- (i) No material for the Internal Assessment Examinations shall be provided by the university.
- (ii) Complete records of the Internal Assessment (Mid Term and Project) i.e., Attendance Sheets (Mid Term and Project both), Evaluated Answer Sheets of Mid Term Examinations, Mid Term Question Papers, Evaluated Project Reports (written submission) and Award Sheets (prepared manually at the time of assessment and online both), shall be maintained by the College in safe custody till the completion of the Degree of respective candidates or the period of five years, whichever is later.
- (iii) University may ask the physical record of any candidate or all candidates from the college(s) for verification purpose or any other requirement within the stipulated period.
