At the outset, the Vice-Chancellor, Dr. Bhimrao Ambedkar Law University welcomed all the Hon'ble Members and presented floral bouquet to the members. Thereafter, the Vice-Chancellor presented the following brief account of the details of activities of the University from its inception till date:-

- Dr. Bhimrao Ambedkar Law University was established by the State Government of Rajasthan, by enacting "Dr. Bhimrao Ambedkar Law University, Jaipur Act, 2019 (Act No.6 of 2019), which received the assent of Hon'ble Governor on 26th February, 2019. Thereafter, the State Government by its Notification No. F.2(9)vidhi/2/2019 dated 26.02.2019 issued the notification of the University.
- The Chancellor, after consultation with the Government of Rajasthan, in exercise of his powers conferred under Section 11 (17) of Dr. Bhimrao Ambedkar Law University, Jaipur Act, 2019, appointed Dr. Dev Swarup as first Vice-Chancellor of

- the University on 27th February 2020 for a period of three years. He joined as its founder Vice-Chancellor on 2nd March, 2020.
- The Vice-Chancellor vide his letter dated 06th March, 2020 formally informed the Bar Council of India about the establishment of the University & its objects and endeavour.
- The Secretary, Higher Education, the Vice-Chancellor and the Registrar collectively launched the Website of the University (www.alujaipur.ac.in) on 22nd April, 2020 digitally, In spite of Lockdown due to Covid-19, it has been visited 48,000 times so far.
- The Vice-Chancellor vide his letter dated 17th March, 2020, formally requested the University Grants Commission, New Delhi for inclusion of the University under Section 2 (f) of UGC Act. The University Grants Commission vide its letter dated 12th & 14th May, 2020 issued the notification with regard to inclusion of Dr.Bhimrao Ambedkar Law University, Jaipur under Section 2(f) of UGC Act 1956.
- The Vice-Chancellor formulated the Vision & Mission of the University reflecting the purpose and perspective. It has been duly uploaded on the Website of the University.
- The Vice-Chancellor vide his letter dated 18th April, 2020 requested the Government to provide temporary building/campus for the University to undertake various activities of the University. The Government as an interim arrangement has allotted the city camp office of the University at RUSA Block, Ground Floor, Shiksha Sankul, Jaipur vide letter dated 24th June, 2020.
- The Vice-Chancellor vide his letter dated 18th April, 2020 requested the Government for allocation of permanent campus of the University. The Government vide its letter dated 22nd July, 2020 authorized the University to have right to use for land, infrastructure and the resources available at Ambedkar Peeth, Mundla, Jamwaramgrah, Jaipur.
- A Cabinet decision has been taken on 2nd September, 2020 for making it as a permanent campus. Accordingly a master plan will be prepared for the proper development of the campus, its landscaping and also to have required infrastructure in a phased manner.
- The Vice-Chancellor vide his letter dated 22nd April, 2020 informed the Government about the provision in the Act with regard to affiliation of all law colleges. The Government vide its order dated 22nd July, 2020 notified that all law colleges of the state, except the constituent colleges of other Universities shall be affiliated to the Dr. Bhimrao Ambedkar Law University Jaipur from the academic Session 2020-21. There are 88 Law Colleges spread across the state.
- The Vice-Chancellor vide his letter dated 27th July 2020 addressed to the respective Vice-Chancellors, requested for adherence to the Government order dated 22nd July, 2020 with regard to affiliation of Law Colleges in letter & spirit.





2. To consider that the Government may be requested to make required nominations for the Selection Committee of the University.

Section 29(1) of Dr. Bhimrao Ambedkar Law University, Jaipur Act, 2019 provides as under:-

"29 (1) The Appointment of teachers and officers of the University shall be made in accordance with provision of the Rajasthan Universities, Teachers and Officers (Selection for Appointment) Act, 1974 (Act No.18 of 1974)."

The Rajasthan University teachers and officers (Selection for Appointment) Act No.18 of 1974 provides the following Three or, as the case may be, two experts to be nominated by the Vice-Chancellor of the University concerned for the selection of the teachers specified at serial numbers 1,2 and 3 in column 1 of the Schedule shall be chosen by him on the advice of a Committee consisting of a member of Rajasthan Public Service Commission to be nominated by the State Government after consultation with the Chairman of the said Commission who will be the Chairman of the Committee, eminent educationist nominated under clause (iii) of sub-section (1) of Section 5 and the members of the Syndicate nominated under clause (iv) of the said sub-section of the said section and said committee shall from out of the panel of names recommended by the Academic Council recommend to the Vice-Chancellor of the University concerned names of at least twelve experts for each Selection Committee which shall be in order of priority.

Accordingly, it was resolved that a request may be made to the Government of Rajasthan for nomination of an eminent educationist by the State Government for a period of one year as suggested under clause (iii) of sub-section (1) of section 5 and similarly one nomination also be made by the Government from the BoM of Dr. Bhimrao Ambedkar Law University, under clause (iv) of sub-section (1) of section 5 for a period of one year. As a procedural requirement besides serving on the selection committees of the University, these two nominees, along with RPSC, will be a part of the committee to finalize the panel of subject experts in Law.

3. To consider the process of Affiliation of all the Law Colleges of Rajasthan except constituent colleges of other universities, for the Academic Session 2020-21.

Section 4 of Dr. Bhimrao Ambedkar Law University, Jaipur Act 2019 provides for the jurisdiction of the University in the following terms:-

- "4. Jurisdiction.= (1) Notwithstanding anything contained in any law for the time being in force, the jurisdiction of the University shall extend to whole of the State of Rajasthan and all Law colleges, except constituent colleges of other Universities, shall be affiliated to the Dr. Bhimrao Ambedkar Law University, Jaipur in accordance with the Statutes, Ordinances and Regulations made under this Act.
 - (2) The State Government may, by order in writing-
 - (a) require any institute, institution or college within the territorial limits of the University to terminate, with effect from such date as may be specified in the order, its association with, or its admission to the privileges of any other University incorporated by law to such extent as may be considered necessary and proper, or
 - (b) exclude, to such extent as may be considered necessary and proper, from association with, or from admission to the privileges of the University constituted by this Act any institute, institution or college specified in the order which, in the opinion of the State Government, is required to be self-governing or to be associated with or admitted to the privileges of, any other University or body.
 - (3) The State Government may, in consultation with the University, by notification published in the Official Gazette, enumerate any Government College situated in the jurisdiction of the University to be a constituent college of the University. All the movable and immovable properties of such colleges shall then vest in the University and the officers, teachers and employees of such colleges, after being found suitable through screening and on fulfilling such terms and conditions as may be laid down in the notification, shall be deemed to be the officers, teachers or, as the case may be, employees of the University."

Accordingly, the Secretary, Higher Education, Government of Rajasthan issued an office order dated 22.07.2020 under Section 4(1) & (2) of the aforesaid Act, whereby it was ordered that all Law colleges situated in the State, except constituent colleges of other universities, shall be run with the affiliation of Dr. Bhimrao Ambedkar Law University, Jaipur. It was also ordered that students

taking admission in the first year of Undergraduate & Postgraduate Law courses (2020-21) shall be enrolled with Dr. Bhimrao Ambedkar Law University, Jaipur

Subsequently, the Vice-Chancellor of Dr. Bhimrao Ambedkar Law University vide his letter dated 27.07.2020 informed and requested the Vice-Chancellors of all universities situated in the State of Rajasthan for necessary action in the matter.

The Registrar of the University also communicated with the Registrars of respective universities for necessary action vide his letters No.F.06II(01)/Academics-II/ALU/2020-21/125-134 dated 21.08.2020 and F.06II(01)/Academics-II/ALU/2020-21/162-171 dated 07.09.2020 and F.06II(01)/Academics-II/ALU/2020-21/276-285 dated 19.09.2020 for necessary action with regard to affiliation of law colleges.

The Vice-Chancellor again on 15th October, 2020 sent a letter to all the Vice-Chancellors of respective universities requesting them to provide the list of all such colleges with documents and specific assessment with regard to whether the colleges are fit or unfit (after inspection) for the affiliation for the academic session 2020-21. Information in this regard is yet to be received from the respective Universities.

The BoM, considering the extraordinary circumstances prevalent due to Covid-19 pandemic and particularly with a view to ensure that affiliation process of law colleges is taken forward and completed for the present academic year 2020-21 in a smooth manner with Dr. Bhimrao Ambedkar Law University, Jaipur, resolved the following:

a. All existing law colleges (except constituent colleges of other universities) in the State of Rajasthan which have been found fit by the respective universities for affiliation for the academic session 2020-21, shall be considered Deemed to be Affiliated with Dr. Bhimrao Ambedkar Law University, Jaipur for the present academic session 2020-21 upon receipt of the relevant documents from the respective Universities, and accordingly all such colleges shall be eligible to admit students in the first year of undergraduate and postgraduate law courses during the present academic year 2020-21.





- b. All students admitted in first year of undergraduate & postgraduate law courses in all such law colleges, as mentioned in 'a' above, shall be enrolled only with Dr. Bhimrao Ambedkar Law University, Jaipur and will be governed accordingly.
- c. For affiliation of law colleges of the state for the academic session 2021-22, the university may undertake the necessary process and procedure.

The Committee after extensive deliberations and due considerations to all the necessary aspects, and keeping in view the syllabus of various law universities and their latest curriculum formulated the guidelines for admissions and syllabus for the following Law Courses for the academic session 2020-21.

<u>Undergraduate:</u>

- (i) B.A.LL.B. (Five years), (Integrated course) (Semester Scheme)(Bi-Semester)
- (ii) LL.B. (Three Years Course), (Annual Scheme)

Postgraduate:

(iii) LL.M. (Two Years Course), (Annual Scheme)

Diploma:

- (iv) One year Diploma in Labour Laws (Annual Scheme)
- (v) One year Diploma in Forensic Science (Annual Scheme)
- (vi) One year Diploma in Criminology (Annual Scheme)

The BoM ratified the decision of the Vice-Chancellor of the constitution of the Committee of the academicians and considered the guidelines for admissions and syllabus formulated by the said committee and resolved as under:

- 1. The Guidelines for the admissions and syllabus formulated by the Committee for the First Year is approved and the same may be implemented from the academic session 2020-21 itself in all the Law Colleges of Rajasthan except constituent colleges of other universities.
 - 2. The Committee mentioned herein may continue till the entire syllabus for remaining period of the respective courses is completed. For this purpose a Sub-Committee of the main Committee is constituted, comprising the following:

nominated by the Vice-Chancellor of the University concerned for the selection of the teachers specified at serial numbers 1,2 and 3 in column 1 of the Schedule shall be chosen by him on the advice of a Committee consisting of a member of Rajasthan Public Service Commission to be nominated by the State Government after consultation with the Chairman of the said Commission who will be the Chairman of the Committee, eminent educationist nominated under clause (iii) of sub-section (1) of Section 5 and the members of the Syndicate nominated under clause (iv) of the said sub-section of the said section and said committee shall from out of the panel of names recommended by the Academic Council recommend to the Vice-Chancellor of the University concerned names of at least twelve experts for each Selection Committee which shall be in order of priority.

Accordingly, it was resolved that a request may be made to the Government of Rajasthan for nomination of an eminent educationist by the State Government for a period of one year as suggested under clause (iii) of sub-section (1) of section 5 and similarly one nomination also be made by the Government from the BoM of Dr. Bhimrao Ambedkar Law University, under clause (iv) of sub-section (1) of section 5 for a period of one year. As a procedural requirement besides serving on the selection committees of the University, these two nominees, along with RPSC, will be a part of the committee to finalize the panel of subject experts in Law.

Action Taken

The Registrar vide letter no. F.I(13) Estt./ALU/2020-21/816 dated 19.11.2020 addressed to Secretary, Higher Education, Government of Rajasthan requested for the Nominees for Selection Committees.

Agenda No.3

To consider the process of Affiliation of all the Law Colleges of Rajasthan except constituent colleges of other universities, for the Academic Session 2020-21.

Resolution

Section 4 of Dr. Bhimrao Ambedkar Law University, Jaipur Act 2019 provides for the jurisdiction of the University in the following terms:-

- "4. Jurisdiction.- (1) Notwithstanding anything contained in any law for the time being in force, the jurisdiction of the University shall extend to whole of the State of Rajasthan and all Law colleges, except constituent colleges of other Universities, shall be affiliated to the Dr. Bhimrao Ambedkar Law University, Jaipur in accordance with the Statutes, Ordinances and Regulations made under this Act.
 - (2) The State Government may, by order in writing-
 - (a) require any institute, institution or college within the territorial limits of the University to terminate, with effect from such date as may be specified in the order, its association with, or its admission to the privileges of any other University incorporated by law to such extent as may be considered necessary and proper, or

- (b) exclude, to such extent as may be considered necessary and proper, from association with, or from admission to the privileges of the University constituted by this Act any institute, institution or college specified in the order which, in the opinion of the State Government, is required to be self-governing or to be associated with or admitted to the privileges of, any other University or body.
- (3) The State Government may, in consultation with the University, by notification published in the Official Gazette, enumerate any Government College situated in the jurisdiction of the University to be a constituent college of the University. All the movable and immovable properties of such colleges shall then vest in the University and the officers, teachers and employees of such colleges, after being found suitable through screening and on fulfilling such terms and conditions as may be laid down in the notification, shall be deemed to be the officers, teachers or, as the case may be, employees of the University."

Accordingly, the Secretary, Higher Education, Government of Rajasthan issued an office order dated 22.07.2020 under Section 4(1) & (2) of the aforesaid Act, whereby it was ordered that all Law colleges situated in the State, except constituent colleges of other universities, shall be run with the affiliation of Dr. Bhimrao Ambedkar Law University, Jaipur. It was also ordered that students taking admission in the first year of Undergraduate & Postgraduate Law courses (2020-21) shall be enrolled with Dr. Bhimrao Ambedkar Law University, Jaipur.

Subsequently, the Vice-Chancellor of Dr. Bhimrao Ambedkar Law University vide his letter dated 27.07.2020 informed and requested the Vice-Chancellors of all universities situated in the State of Rajasthan for necessary action in the matter.

The Registrar of the University also communicated with the Registrars of respective universities for necessary action vide his letters No.F.06II(01)/Academics-II/ALU/2020-21/125-134 dated 21.08.2020 and F.06II(01)/Academics-II/ALU/2020-21/162-171 dated 07.09.2020 and F.06II(01)/Academics-II/ALU/2020-21/276-285 dated 19.09.2020 for necessary action with regard to affiliation of law colleges.

The Vice-Chancellor again on 15th October, 2020 sent a letter to all the Vice-Chancellors of respective universities requesting them to provide the list of all such colleges with documents and specific assessment with regard to whether the colleges are fit or unfit (after inspection) for the affiliation for the academic session 2020-21. Information in this regard is yet to be received from the respective Universities.

The BoM, considering the extraordinary circumstances prevalent due to Covid-19 pandemic and particularly with a view to ensure that affiliation process of law colleges is taken forward and completed for the present academic year 2020-21 in a smooth manner with Dr. Bhimrao Ambedkar Law University, Jaipur, resolved the following:

- a. All existing law colleges (except constituent colleges of other universities) in the State of Rajasthan which have been found fit by the respective universities for affiliation for the academic session 2020-21, shall be considered Deemed to be Affiliated with Dr. Bhimrao Ambedkar Law University, Jaipur for the present academic session 2020-21 upon receipt of the relevant documents from the respective Universities, and accordingly all such colleges shall be eligible to admit students in the first year of undergraduate and postgraduate law courses during the present academic year 2020-21.
- b. All students admitted in first year of undergraduate & postgraduate law courses in all such law colleges, as mentioned in 'a' above, shall be enrolled only with Dr. Bhimrao Ambedkar Law University, Jaipur and will be governed accordingly.
- c. For affiliation of law colleges of the state for the academic session 2021-22, the university may undertake the necessary process and procedure.

Action Taken

To undertake the process of affiliation of all the Law Colleges, communications were sent to concerned Vice-Chancellors and respective colleges for necessary action. The efforts are being made in this regard.

Agenda No.4

To consider the adoption/implementation and approval of uniform syllabus for academic programmes to be conducted by various law colleges of the State of Rajasthan affiliated with the University from the academic session 2020-21 onwards.

Resolution

Realizing the importance and immediate need and specially in the absence of academic bodies like CoC, BoS, and Academic Council etc, the Vice-Chancellor constituted the following committee of academicians with a task to suggest the uniform syllabus for the academic programmes commencing from the academic session 2020-21:

The Committee after extensive deliberations and due considerations to all the necessary aspects, and keeping in view the syllabus of various law universities and their latest curriculum formulated the guidelines for admissions and syllabus for the following Law Courses for the academic session 2020-21.

<u>Undergraduate:</u>

- (i) B.A.LL.B. (Five years), (Integrated course) (Semester Scheme)(Bi-Semester)
- (ii) LL.B. (Three Years Course), (Annual Scheme)

Postgraduate:

(iii) LL.M. (Two Years Course), (Annual Scheme)

Diploma:

- (iv) One year Diploma in Labour Laws (Annual Scheme)
- (v) One year Diploma in Forensic Science (Annual Scheme)
- (vi) One year Diploma in Criminology (Annual Scheme)

The BoM ratified the decision of the Vice-Chancellor of the constitution of the Committee of the academicians and considered the guidelines for admissions and syllabus formulated by the said committee and resolved as under:

1. The Guidelines for the admissions and syllabus formulated by the Committee for the First Year is approved and the same may be implemented from the academic session 2020-21 itself in all the Law Colleges of Rajasthan except constituent colleges of other universities.

- 2. The Committee mentioned herein may continue till the entire syllabus for remaining period of the respective courses is completed. For this purpose a Sub-Committee of the main Committee is constituted, comprising the following:
- (a) Prof. K.L. Sharma

The Committee will formulate its proceedings in consultation with the main committee and Prof. Mridul Srivastav (Consultant Academics for the University) will coordinate the same.

2. The Diploma in "LAW AND SOCIAL JUSTICE" will also be introduced at the earliest. The suggestion made by Smt. Shuchi Sharma, was appreciated by the entire BoM and it was resolved to accept the same unanimously. The committee already constituted for formulation of syllabus for various academic programmes in Law will formulate the syllabus for this programme as well.

Action Taken

The guidelines for admissions and syllabus for the academic programmes were formulated and finalized by the Committee as per the details given below:

Undergraduate:

- (i) B.A.LL.B. (Five years), (Integrated course) (I& II Semester Scheme)
- (ii) BBA. LL.B. (Five years), (Integrated course) (I& II Semester Scheme)
- (iii) LL.B. (Three Years Course), (I Year)

Postgraduate:

- (iv) LL.M. (One Year Course), (Semester-I) For on Campus/University Students.
- (v) LL.M. (Two Years, Annual Scheme) (Part-I) For All Affiliated Law Colleges.

Diploma:

- (vi) One year Diploma in Labour Laws (Annual Scheme)
- (vii) One year Diploma in Forensic Science (Annual Scheme)
- (viii) One year Diploma in Criminology (Annual Scheme)

The same was approved by the Vice-Chancellor of the University and uploaded on the University website.






PILLAR OF CONSTITUTION-Material detail






To report the approval of the Government for the Purchase of one Ciaz Car for the Vice-Chancellor.
