NOTIFICATION

Subject: Submission of Online and Hard Copy of Applications for revisiting Affiliations in compliance with the directions of the Bar Council of India and granting fresh/ extending provisional /continuing permanent affiliation and increase in intake for the Academic Session 2027-28.

In pursuance of the directions of Bar Council of India vide Notification No. BCI:D:4697/2026 dated 23 July 2026, the Rules of Legal Education, 2008, the provisions of the Dr. Bhimrao Ambedkar Law University Act, the applicable Statutes, Ordinances and Affiliation Regulations, all affiliated and eligible law colleges are hereby informed that applications for revisiting affiliations and granting fresh/ extending provisional /continuing permanent affiliations and increase in intake for the Academic Session 2027-28 shall be submitted in the revised Application Form prescribed by the University.

The revised Application Form has been designed to facilitate comprehensive verification of compliance with the standards prescribed by the Bar Council of India and shall form the basis of scrutiny and physical inspection by the University.

Accordingly, every institution shall furnish complete information and documentary evidence relating to, inter alia:

1. Valid and subsisting Bar Council of India approval for every programme, course, section and approved intake.
2. Government NoCs and other statutory permissions wherever applicable.
3. Exclusive full-time Principal and faculty members, qualifications, appointment orders, joining reports, workload, attendance records, salary paid through banking channels and all service records.
4. Land, building, classrooms, moot court hall, seminar hall, library, legal aid clinic, ICT facilities, administrative offices and all infrastructure prescribed under the Rules of Legal Education, 2008.
5. Student admissions, sanctioned intake, attendance records, class timetables and academic schedules.
6. Library accession registers, subscriptions to journals and online legal databases.
7. Geo-tagged photographs and all other documents prescribed in the Application Form.

Every institution shall submit:

- Online Application through the University website.
- One hard copy of the duly signed application along with all annexures and supporting documents.

On submission of application form can be made on or before 4th August, 2026. Hard copy of the same shall reach the University within three days of online submission.

No application received after the prescribed date shall ordinarily be entertained unless specifically permitted by the competent authority with existing late fee.

Affiliation fee structure for submission of applications is as under for the academic session 2027-28:

Other terms and conditions are as under:

1. Cost of online application form for affiliation shall be Rs. 1,000/- per Programme.
2. The colleges applying for affiliation are required to pay inspection fee of Rs. 25,000/- per Programme.
3. The colleges having permanent affiliation are required to pay only inspection fee of Rs. 25,000/- and cost of application form Rs. 1,000/- per Programme.
4. The existing colleges will be required to fill up AISHE code provided by the MHRD and NAAC certifications by the National Assessment and Accreditation Council (NAAC).
5. Each college will carefully choose the category of affiliation otherwise neither the category will be changed nor the fee will be returned/adjusted.
6. The affiliation fee will be deposited by the college in the following account, through their respective virtual bank account. which is provided by the University. No other mode of payment will be accepted.
