PAPER 6.5:

OFFENCES AGAINST WOMEN AND CHILDREN

NOTE:

This substituted syllabus shall be applicable to the candidates who have sought admission in the batch of 2022-23 and are appearing first time in semester sixth examination in 2024-25. It shall also be applicable for the admitted Batch of 2023-24 and will appear first time in semester sixth examination in 2025-26.

SCHEME OF PAPER:

This paper shall consist of following two parts:

(a) Written paper — 70 marks

The candidate must pass in part (a) and (b) separately. For passing, he shall be required to obtain 36 percent marks in each part, i.e. 25 marks out of 70 and 11 marks out of 30 marks.

- (1) The question paper shall be divided into two (02) Parts viz. Part A and Part B.
- (2) Part A shall consist of five (05) compulsory questions of two (02) marks each whereas Part B shall consist of seven (07) questions. The Candidate is required to attempt any four (04) questions. All questions carry equal marks.
- (3) The prescribed syllabus includes latest amendments in the subject wherever applicable.

INTRODUCTION:

The course aims to create awareness as to importance and role of women and Child in society through the medium of law. It also focuses on women and child welfare laws.

In the past decade research has documented the growing magnitude of violence against women and children. Victims of violence/crime of any type fear stigmatization or societal condemnation and thus often hesitate to report crimes. The issue is compounded by the fact that for women and children the perpetrators are often people they know and because some countries lack laws or regulations protecting victims. The violence/crime poses a high burden on global health and that violence against women and children is common and universal. When directed against women or children, this violence can take a number of forms, including, but not limited to, sexual violence, intimate partner violence, child abuse and neglect, bullying, teen dating violence, trafficking, and elder abuse. The majority of offences against women and children are perpetrated by partners, family members, friends, or acquaintances, so that most violence against women and children takes place in the form of intimate partner violence, family violence, or school violence.

COURSE OBJECTIVES: The primary objectives of this course are:

- 1. To understand the issue of violence against women and children and its implications across all areas and providing knowledge required to play a role in shaping social policy responses.
- 2. To provide the highlights of different legislative enactments dealing with various crimes against women and children.
- 3. To Emphasize on providing a holistic understanding of criminal law by focusing on protecting women and children.
- 4. To understand the laws of crime and a legal aptitude for analyzing problems.
