GUIDELINES RELATING TO CONDUCT AND EVALUATION OF EXAMINATIONS FOR PROGRAMME OF LL.B. DEGREE THREE YEARS (ANNUAL SCHEME) FOR AFFILIATED COLLEGES FROM SESSION 2023-24

A Bachelor's Degree Programme in Law (LL.B.) for Affiliated Colleges shall be of Three Years (Annual Scheme). These guidelines shall come into force from the Session 2023-24 onwards. There shall be a Three-Year Course for the degree of LL.B. for which the teaching shall be conducted through the lecture method, practical learning and class performance during the session and examination shall be conducted through written papers, practical and viva-voce at the end of each Session.

THREE YEAR LL.B. COURSE: 1. (II)

- 1. LL.B: First Year Examination at the end of the First Year.
- 2. LL.B: Second Year Examination at the end of the Second Year.
- 3. LL.B: Third Year Examination at the end of the Third Year.

I. ELIGIBILITY:

- 1. A candidate is required 75% attendance in a regular course of study in each year pursuing from the University/ or from an affiliated College of this university for admitting the candidate in examination of LL.B. First Year, Second Year and Third Year.
- 2. A candidate who has completed a regular course of study from the University/or from an affiliated College for First Year of LL.B. will, subject to the other provisions of the Rules and Regulations, be admitted to the First Year Examination of the LL.B. Course depending on the course he/she has taken.
- 3. A candidate who after passing the examination of the First Year, has completed a regular course of study from the University or from an affiliated college for the Second Year of LL.B. course will, subject to the other provisions of the Rules and Regulations, be admitted to the Second Year Examination of LL.B. course, as the case may be.
- 4. A Candidate who after passing the examination of the Second Year has completed a regular course of study from the University or from an affiliated college for the Third Year of LL.B. course shall subject to the other provisions of the Rules and Regulations be admitted to the Third Year Examination of LL.B. course, as the case may be.
- 5. A candidate who has appeared at and passed, after having undergone a regular course of study in the Third Year of the LL.B. course subject to the other provisions shall be awarded the degree of Bachelor of Laws. Every candidate for the Three Years Course

- for the degree of LL.B. shall present himself/herself for examination in the papers prescribed in the Regulations in force.
- 6. Each theory paper in LL.B. First Year, Second Year and Third Year examination shall be of 100 marks, division of the marks in each subject to the theory/practical in the respective papers prescribed in the syllabus, further, the theory examination shall be of three hours duration. In each year of LLB. First Year, Second Year and Third Year, the Practical paper shall be divided into two parts: Part "A" shall be of Written Examination of 80 marks and Part "B" shall be of 20 marks EXCEPT THE ONE SOLE PRACTICAL PAPER CODE: 1529: MOOT COURT EXERCISE AND INTERNSHIP OF 100 MARKS IN LL.B. THIRD YEAR EXAMINATION. A candidate shall be required to pass separately in theory and practical examinations. If an examinee appears in either of the Theory/Practical paper in the Examination, such candidate shall not be permitted to appear again in such part of that paper if he/she pass. In such part of that paper, marks awarded to him/her shall carry forward in the next ensuing examination.

ALL PRACTICAL/VIVA VOCE EXAMINATION SHALL BE CONDUCTED BY INTERNAL AND EXTERNAL EXAMINER AND THE DECISION OF THE EXTERNAL EXAMINER SHALL BE FINAL AND BINDING.

- 7. Wherever, any option(s) in any paper has been provided in the syllabus of LL.B. First Year, Second Year and Third Year, the Principal or the Head of the Unit may determine only at the beginning of each session, the option or the options in which instructions may be provided during that session. The choice of the candidate shall be limited to the options so provided by the authority for imparting instructions. The Principal or the Head of the Unit may only determine it, subject to the prior approval of the University.
- 8. A candidate may be permitted by the Principal or Head of the Unit to appear in one additional paper at LL.B. First Year, Second Year and Third Year examination subject to the prior approval of the University. No teaching facility shall be provided for such additional paper in which he/she appears and the marks obtained therein shall not be considered at the time of working out his/her result but the marks obtained in such additional paper shall be displayed if the candidate secures a minimum 36% marks at the examination in such additional paper, failing which no further opportunity shall be provided to the candidate. Revaluation shall not be permitted in such additional paper.
- 9. The Vice-Chancellor may, on the recommendation of the Dean, Faculty of Law or the Committee authorized by the University for this purpose, permit transfer of a candidate within the affiliated colleges of this University who has passed in any year of the LL.B. Examination from this University and also, he/she has cleared all the papers of all previous years in which he/ she has appeared. Such transfer from other University may also be permitted by the Vice-Chancellor on the recommendation of the Dean, Faculty of Law or the Committee authorized by the University for this purpose if the examination scheme of that University which in detail is the same or similar to the scheme of this University of LL.B. Examination to such year of the

- LL.B. course and on such terms and conditions as may be laid down by this University.
- 9.1. If during any Academic Year any student (who is a regular and bonafide student of any affiliated college of this University) desires to leave any affiliated college of this University of one district of Rajasthan to join another affiliated college of this University in another district of Rajasthan State, then he/she shall obtain a written permission from the Principal of such college concerned in which he/she is studying after making payment of college dues and refunding whatever scholarship etc. which might have been granted to him/her. Further, the student must also obtain the permission from the concerned college in which he desires to seek the admission. A student shall not be allowed to take transfer during the session from one college to another college of this University after his/her name has been sent for the Examination.

In genuine cases, however, as that of transfer of Parent/Guardian of the student in Government Services from one place or district to another place or district, on proof of relevant documents being sent to the University through the Principal of the concerned colleges, such student could be permitted to take admission in any other affiliated college of such other place/district in which the transfer of the guardian/parent has been made.

Attendance of such candidate in the college where he seeks the admission will be taken into account by the old institution from which he is transferred and sent to the University by it. The examination centre of such a student shall be in the college where the transfer is sought by the student.

10. The marks obtained by the candidate in all the examinations of LL.B. First Year, Second Year and Third Year for award of LL.B. degree shall be consolidated for preparing and declaring the result with merit.

II. EXAMINATION AND EVALUATION:

- 1.(a) A candidate required to pass shall obtain at least 36% marks in LL.B. First Year, Second Year and Third Year examinations in each Individual paper and 48% marks in the aggregate in each year respectively of all Law Papers during the completion of his/her Three Years Course. After completing Three Years LL.B. Course as per above, he/ she may be awarded the degree of Bachelor of Laws.
- (b) A candidate who fails in any year during the Three Years LL.B. course shall be eligible for promotion to either LL.B. Second Year or Third Year subject to that he/she has secured 36% marks in individual paper and 48% marks in aggregate in at least six (06) papers out of ten (10) papers by the candidate in the examination in which he/she has appeared. Such eligible candidate shall only be promoted in the next higher class.

The candidate who is promoted in the next higher class shall be eligible to reappear only in four (04) subjects/papers in consecutive examinations to secure 36% marks in each Individual paper and 48% marks in the aggregate of all Law papers of that class.

(c) If a candidate could not pass LL.B. First Year, Second Year or Third Year examination within three consecutive attempts, from the year in which he has first

- appeared and failed; then he/she shall have to repeat the same class & appear in all the papers in the examination afresh.
- (d) There shall be a supplementary examination only at the end of the main examination of LL.B. Third Year in which the candidate of LL.B. Third Year and LL.B. Second Year, if eligible as per rules he /she may appear in the remaining paper(s) to succeed in the following examination. There shall be no improvement scheme in the three years of LL.B. course.
- (e) THERE SHALL BE MAXIMUM FIVE (05) YEARS DURATION TO COMPLETE THE LL.B. COURSE.
- 2. Division shall be awarded in the LL.B. Third Year on the basis of the consolidated marks obtained by the candidate in all the three years examinations of LL.B. course.
- 3. The successful candidate who secured 60% or more marks shall be placed in the First Division and who secured 48% or more marks and less than 60% marks shall be placed in the Second Division. A candidate obtaining aggregate of 75% and above marks shall be placed in First Class with Distinction, provided the candidate has passed all the papers/subjects in the first attempt and without award of Grace in any subject/paper or in Aggregate.

III. GRACE MARKS:

- a) Marks with (*) against a subject in the mark sheet denote Fail /Grace in the subject/paper. To pass, one percent (01%) marks (to be rounded off at higher side, in case of fraction) of the maximum marks of appeared subject(s) / paper(s) by the examinee shall be awarded to him/her divided into the maximum of four subject(s) / paper(s). Further such grace marks shall only be awarded to him/her either in individual subject(s) / paper(s), theory papers, practicals, sessionals, viva-voce or the aggregate as the case may be in which minimum pass marks have been prescribed, divided into the maximum of four subject(s) / paper(s) or for making his/her 48% i.e. aggregate marks to pass the examination of that class.
- b) Non-Appearance of a candidate in any paper will make him/her ineligible for grace marks. The place of a passed candidate in the examination list will, however be determined by the aggregate marks he/she secures from the examiner and he/she will not by the award of grace marks become entitled to a higher division.
- c) Distinction won in any subject at the examination is not to be forfeited on the score that a candidate has secured grace to pass the examination.

NOTE: The Grace marks will be awarded only if Candidate appears in all the papers prescribed for the main examination. In case the examinee appearing in due / back paper, the general rule (a) provided above shall be applicable.

IV. REVALUATION:

1. Re-evaluation shall only be permitted to the candidate to apply only in maximum of four (04) theory papers of the main examination. Re-evaluation

shall also be permitted in due / back paper(s) and Supplementary examinations. However, the candidate may apply for revaluation only in the 50% of the total number of papers in which he/she has appeared in the due / back paper(s) and Supplementary examinations.

Re-evaluation includes Scrutiny of marks. No separate application shall be accepted for Scrutiny of marks. The candidate may apply for re-evaluation within 15 Days from the date of the declaration of main examination result declared or date decided by COE, as per the convenience of the University. Result declared as a clearance of RL, RW/EX, UM category shall not be entitled to apply for Re-evaluation, after the expiring of the last date for applying the Re-evaluation. Rules, Regulations relating to fee and procedure for Re-evaluation shall be available on University website (www.alujaipur.ac.in). Re-evaluation fee may be revised by the University.

2. In case of any error being detected during the preparation of result/marks sheet or brought to notice afterwards, the University shall have an authority to make the corrections accordingly and may direct such candidate to return the original mark sheet to the University.

V. RANKING/ORDER OF MERIT:

Ranking/Order of Merit shall be based on the aggregate marks secured for all the papers of all Academic Years of the course taken together subject to the condition that the student has passed all the papers/ subjects in his/her first attempt and without award of Grace Marks in any subject/paper or in Aggregate. Separate ranking will not be there for each of the subjects/years.

Moreover, the result of Revaluation shall also be considered for the award of the merit to the candidate for the main examination.

VI. AWARD OF DEGREE:

A student shall be awarded LL.B. Degree if:

- 1. He / She has enrolled himself/herself, as a regular student, undergone the prescribed course of studies, successfully completed the theory examinations/Practicals/Vivavoce etc. as specified in the curriculum within the stipulated time and secured the minimum prescribed marks in all the courses.
- 2. There are no dues outstanding in his/her name.
- 3. No disciplinary action is pending against him/her.
- 4. He/She fulfills the complete requirements as prescribed in course curriculum and examination schemes.
- 5. The degree shall be conferred in Convocation of the University. Meanwhile, University shall issue Provisional Certificate as a proof of completion of course successfully.
