- 1. The bidders who are interested in bidding can download bid documents form on https://eproc.rajasthan.gov.in. The bid document can be seen and downloaded on https://alujaipur.ac.in and website https://sppp.rajasthan.gov.in also.
- 2. Bids are to be submitted online in electronic format on website https://eproc.rajasthan.gov.in.
- 3. Bidders who wish to participate in this bid will have to register on https://eproc.rajasthan.gov.in.
- 4. Bidders will have to procure Digital Signature Certificate (Type II or Type III) as per Information Technology Act. 2000 using which they can sign their electronic bids. or they may contact e-Procurement Cell, Department of IT&C, Government of Rajasthan for further assistance. Bidders who already have a valid Digital Certificate need not to procure a new Digital Certificate.
- The Bidding comprises of two part system. The Technical Bid and the Financial Bid. Manually bid not be accepted.
- 6. Bidder shall submit their offer on-line in Electronic formats both technical and financial proposal. Demand Drafts for Bid Document fee, e-bid processing fee and Bid Security Amount shall be submitted manually in the office to the Tendering Authority within the prescribed time. However, the scanned copies of Demand Draft and Bid Security Amount shall be uploaded along with the online bid.
- 7. If, Bid Fee, RISL e-bid processing fee and bid security amount are not submitted within the prescribed time, then the bid shall be rejected.

GENERAL TERMS AND CONDITIONS

Sub: - Notice Inviting Bid for "Procurement of Services of Consultancy for Coordination" of Dr. Bhimrao Ambedkar Law University, Jaipur.

- Parties: The parties to the contract are the Consultant contractor (the Bidder) to whom
 the work has been awarded) and the Registrar, Dr. Bhimrao Ambedkar Law University,
 Jaipur.
- 2. Addresses:- For all purpose of the contract including arbitration thereunder, the address of the Consultant mentioned in the Bid shall be final unless the contractor notifies a change of address and contact number(s) by a separate letter sent by registered post with Acknowledgement Due to the Dr. Bhimrao Ambedkar Law University, Jaipur. The Consultant shall be solely responsible for the consequences of any omission or error to notify change of address and contact number(s) in the aforesaid manner.
- 3. Bid Security: Bid Security of Rs. 24,000/- by Demand Draft/Bankers Cheque in the favour of Dr. Bhimrao Ambedkar Law University, Jaipur.
 - 3.1 No request for transfer of any previous deposit of Bid Security & Performance Security or adjustment against any pending bill held by the Dr. Bhimrao Ambedkar Law University, Jaipur in respect of any previous work will be entertained.
 - 3.2 Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid banker cheque/demand draft of bid security will be forfeited by the University.
 - 3.3 The Bid without Bid security will be summarily rejected.
- 4. Preparation and submission of Bid:-

The Bid should be submitted in two parts namely:-

Firstly Technical Bid (in form given in **Annexure-A**) and Secondly Financial Bid (in Form given in **Annexure-K** each should be submitted electronically.

The Financial bid of only technically qualified bidders shall be opened. The date & time for opening of financial bid will be informed separately to the technically qualified bidders by e-mail.

- (1) The Bidder should sign and affix his/her stamp at each page of the Bid and all its Annexure as the acceptance of the offer by the Bidder will be deemed as a contract NO PAGE SHOULD BE REMOVED/DETACHED FROM THIS TENDER DOCUMENT.
- 5. Technical Bid:- The Technical bid should be submitted electronically in form given in annexure-A with Bankers Cheque/Demand Draft of Rs. 500/- for tender document fee in favor of Dr. Bhimrao Ambedkar Law University, Jaipur and the Bankers Cheque /Demand Draft of Rs. 500/- for Processing fees in favour of MD, RISL, Jaipur.

Along with registration particulars, copy of PAN number & issued in favor of the bidder, full details of information sought for in the Annexure-A.

- 6. Financial Bid:- The Financial Bid should also be submitted electronically in the BOQ given in Annexure-K. Hard copy is not accepted in any circumstance. The Financial Bid of those Bidder who are found technically qualified, will be opened on a specified date and time to be intimated to the respective qualified Bidders by e-mail.
 - 6.1 Terms of payment as stated in the Bid Document shall be final.
 - 6.2 At the time of payment of bills, the taxes liable to be deducted, if any, shall be deducted at source as per Government rules and guidelines as may be prevailing at the time of payment.
- 7. Validity of the Bids: 90 days

 The bids shall be valid for a period of 90 days from the date of opening of technical bid.
- 8. Opening of Bid:-
 - The Bid is at liberty either himself or authorize, not more than one representative to be present at the time of opening of the Bid. The representative attending the opening of the Bid on behalf of the Bidder should bring with him a letter of authority from the Bidder and proof of identification.
- 9. Criteria for Evaluation of Bid:- The Technical Bids will be opened by the Procurement committee of the University at office of the Registrar, Dr. Bhimrao Ambedkar Law University, Jaipur in the presence of such Bidder or their representatives who may wish to be present.
 - 10.1 The Financial Bids of only those Bidders (to be informed after technical evaluation) will be opened in the presence of those technically qualified Bidders or their representatives whose technical Bids are accepted and who wish to be present.
- 10. The contract shall commence from the day of agreement. To begin with the contract will be for one year initially extendable as per RTPP Act & rules if performance/ service is found satisfactory on review after one year. The contract so awarded can be terminated by Dr. Bhimrao Ambedkar Law University, Jaipur at any time without any notice or conveying any reason thereof.
- 11. Right of Acceptance: The Dr. Bhimrao Ambedkar Law University, Jaipur reserves all rights to reject any Bid including of those Bidders who fail to comply with the instructions without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific tender. The decision of the competent Authority of the Dr. Bhimrao Ambedkar Law University, Jaipur in this regard shall be final and binding.

The Tendering Authority reserves the right to open Financial Bid even if one Bidder qualifies the Technical Bid or only one Bid is received in response to the Bid Notice. However in the case of one Bid the power to negotiate with the Bidder will be reserved with the Procuring Entity.

11.1 Any failure on the part of the **Consultant** to observe the prescribed procedure and any attempt to canvass for the work will prejudice the contractor's quotations.

11.2 Communication of Acceptance: - Successful Bidder will be informed as early as possible of the acceptance of their tender by way of e-mail or telephonically followed by hard copy of letter.

- 12. Bid Security Deposit: Bid Security of Rs. 24,000/- by Demand Draft/Bankers Cheque in the favor of Dr. Bhimrao Ambedkar Law University, Jaipur.
- 13. Work Performance Security Deposit: 2.5% (up to 31-03-2023 and there after as per rules of Finance Department) amount of Contract/Agreement/Work order Value will be deposited by the successful bidder by Demand Draft/Bankers Cheque in the favor of Dr. Bhimrao Ambedkar Law University, Jaipur within 15 days of issuing work order. In addition to Performance Security as specified above an Additional Performance Security shall also be taken from the successful bidder in case of unbalanced bid as per rule 75 A of RTPP Rules 2013.
- 14. The Bankers Cheque /Demand Draft of work performance security can be forfeited by order of the competent authority of the Dr. Bhimrao Ambedkar Law University, Jaipur in the event of any breach or negligence or non- observance of any terms/ condition of contract or for unsatisfactory performance or for non- acceptance of the work order. On expiry of the contract, such portion of the said banker Cheque/Demand Draft as may be considered by the Dr. Bhimrao Ambedkar Law University, Jaipur sufficient to cover any incorrect or excess payments made on the bills to the firm, shall, be retained until the final audit report on the account of firm's bill has been received and examined.

16. Breach of Terms and Conditions: -

In case of breach of any of terms and conditions mentioned above, the Competent Authority will have the right to cancel the work order without assigning any reason thereof, and nothing will be payable by the Dr. Bhimrao Ambedkar Law University, Jaipur in that event and the Performance Security in the form of Bankers Cheque/Demand Draft shall be forfeited.

17. The Bid is not transferable.

18. Terms of payment: -

18.1 Neither payment shall be made in advance nor any loan from any bank or financial institution recommended on the basis of the order of award of work nor does the University take any responsibility for any kind of loan/mortgage taken by the firm or contractor, as the case may be, from anywhere.

- 18.5 No advance for providing services of Consultancy for Coordination "shall be given by Dr. Bhimrao Ambedkar Law University, Jaipur.
- 19 If any difference arises concerning this Agreement, its interpretation on the payment to be made thereunder, the same shall be settled by mutual consultations and negotiations. If attempts for Conciliation do not yield any results within a period of 10 days, either of the parties may make a request to the other party for submission of the dispute for decision to the Vice- Chancellor Dr. Bhimrao Ambedkar Law University. The decision taken by Vice-Chancellor shall be applicable and final.

20 Termination of Assignment:

The University can terminate the assignment any time without assigning any reason.

- 21 The Bidder will be bound by the details furnished by him/her to the University, while submitting the bid or at the subsequent stage. In case of any of such documents furnished by him/her is found to be false at any stage, it would be deemed to be a breach of Terms of the Contract making he/she liable for legal action besides Termination of Contract.
- 22 The bidder should have not been blacklisted by any of the Govt. Department/Public Sector undertakings and No vigilance inquiry or Criminal case should be pending against the firm on the last date of submission of bid.
- 23 Bids uploaded with incomplete information and not conforming to the requirements are liable to be rejected.
- 24 Each page of the Bid document should be signed by the bidder with the seal as a confirmation of accepting all the conditions of the bid.
- 25 Dr. Bhimrao Ambedkar Law University may in its sole discretion and at any time during the processing of Bids may disqualify any Bidder from the bidding if the Bidder has;
 - (a) Made misleading or false representations in the forms, Statements & attachments submitted in the proof of eligibility requirements
 - (b) If found to have a record of poor performance such as abandoning works, not properly completing the contracts, delaying completion, being involved in litigation or financial failure etc.
 - (c) Uploaded Bid document, which is not accompanied by required documents and Bid Security declaration.
